

#### The Growing Crisis in Louisiana

Vector-borne illnesses—particularly those transmitted by ticks—represent a growing and urgent public health threat. Reported cases have more than tripled nationwide since 2004, and ticks now account for 95% of all vector-borne diseases reported in the U.S. Yet these numbers are significantly underreported due to diagnostic challenges and gaps in clinician awareness.

**Here in Louisiana**, we tend to be more familiar with mosquitoes, but tick-borne illness is a real and rising concern:

- Over 1,000 canine cases reported in 2024 alone—early indicators of human exposure
- A 2018 study confirmed Lyme-carrying ticks in Louisiana parishes previously undocumented
- Many families and health professionals remain unaware of the threat

#### Jack's Story: Why This Is Personal

Eleven years ago, my son Jack was a healthy 11-year-old tournament soccer player. Then everything changed. He developed flu-like symptoms, extreme fatigue, and abdominal pain. Within weeks, he experienced multisystem symptoms, including temporary blindness. He went from athlete to hospital bed—missing almost two years of school.

We saw 40 doctors across 19 specialties. Not one asked about tick or animal exposure. After 18 months of misdiagnoses and over \$100,000 in medical bills, we found help through a One Health approach. A physician scientist and veterinary internist working together diagnosed Jack with Bartonellosis and Babesia—both carried by ticks. After 4.5 years of treatment, he is finally healthy and finishing his senior year at McNeese State University.



As a 25-year educator and Chair of the U.S. One Health Education Team, I've discovered a critical failure in our system:

- Children aged 5-9 are at highest risk for tick-borne diseases
- 200 children are diagnosed with Lyme disease daily
- K-12 National Health Education Standards do not include Vector-borne diseases, Zoonotic diseases, nor their prevention strategies (as welllas other One Health topics)

We're not just failing to prevent illness—we're failing to empower young people with the knowledge they need to protect themselves.

With climate change expanding tick, flea, & mosquito habitats and lengthening transmission seasons, we must act now. Louisiana One Health in Action bridges these critical gaps by:

- Bringing together human, animal, and environmental health professionals
- Educating families about risks they don't always learn in school or doctor's offices
- Providing practical prevention strategies
- Creating a community of awareness that can save lives



# **Purpose of Form**

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

Form 1099-INT (interest earned or paid)

- transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)
- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See What is backup withholding, later.
